

Widget User License Agreement

Terms of Use

The terms in this Widget User License Agreement («WULA») govern your use of the 2themoon widget and may be changed by 2THEMOON.CLUB.LIMITED («2THEMOON») at any time without notice. Widget, as defined below, provides access to content owned by 2THEMOON within or connecting to web sites or domains operated by 2THEMOON.

Description

Widgets are free content modules offered by 2THEMOON for personal or non-commercial use of the 2THEMOON Widget («Widget»). Any other uses, including without limitation the incorporation of advertising into, or the placement of advertising associated with or targeted toward, the Widget content, are strictly prohibited, except where provided by separate written agreement with 2THEMOON. License Grant
